**AGENDA**

**1. Background**

- a. A proposed new native title claim that extends the southern boundary of Gingirana claim is ready to be filed.
- b. Before a new native title claim can be filed, those people on the claim must meet and 'authorise' one or more of that group to file the new claim on behalf of everyone. This is called an 'Authorisation meeting'.

**2. Update on Research and Consultation to Date**

- a. Central Desert will provide an update on the process and consultation that has been undertaken to prepare for the Authorisation Meeting and the filing of a new native title claim.

**3. Authorisation to bring the new native title claim**

- a. **Claim Boundary** – Confirm the boundary of the proposed new claim.

- b. **Claim Group Description** – Confirm who is included in the claim.
- c. **Applicant** – Choose a person or people to be the ‘Applicant’. (It is the Applicant’s job to bring the native title application on behalf of all the other people on the claim).
- d. **Claim Name** – Choose a name for the claim.

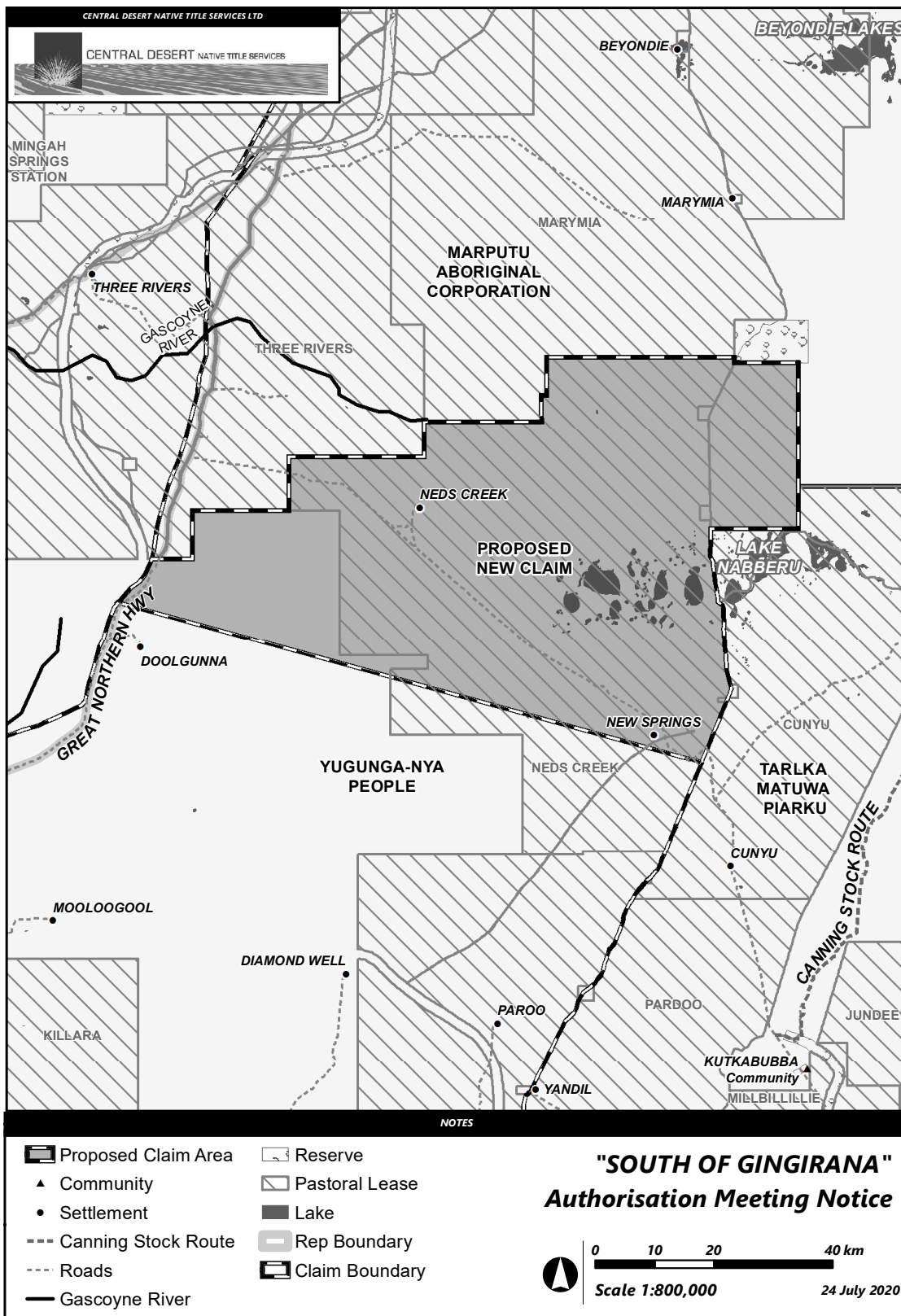
